6. leden 2021 byl pro americkou pravici <u>katastrofou</u>. Navzdory emocionálnímu uspokojení, které někteří pociťovali, nepokoje v Kapitolu zdiskreditovaly prezidenta Donalda Trumpa, umožnily levici označit konzervativce za výtržníky, ospravedlnily ještě větší represe a donutily republikány, kteří vyšetřovali volby v roce 2020, k úplnému ústupu.

Kongres odsoudil prezidenta za údajné zahájení povstání, ale pokud by chtěl převrat, mohl vyzvat dav, aby dobyl Kapitol. <u>Místo toho jim</u> kromě toho , že je varoval: "Pokud nebudete bojovat jako čert, už nebudete mít žádnou zemi," řekl j<u>im</u>, aby "podpořte naši Kapitolskou policii a vymáhání práva", "zůstaňte pokojní". a pak konečně "jdi domů s láskou a v míru". Sociální sítě ho zakázaly a usvědčily ho právě z obvinění, kvůli kterým ho Senát zprostil viny. Bylo to povstání? Máme trestní stíhání a dokonce i několik <u>odsouzení</u> za " <u>pobuřující spiknutí</u> ", ale žádný vyrovnaný člověk nemůže uvěřit, že výtržníci, kteří vtrhli do Kapitolu, byli součástí plánu na svržení vlády Spojených států.

Zdánlivé zoufalství vládních úředníků, novinářů a politiků, aby se nepokoje ze 6. ledna jevily jako zásadní hrozba pro republiku, vedlo některé k domněnce, že celá věc je podvod – vnitřní práce zpravodajských služeb. Místo toho se zdá, že vládní úředníci, novináři a politici z obou stran touží skrývat, co se stalo – a to je přesně to, co radikalizuje lidi a podněcuje "konspirační teorie". Jde o chování paranoidního režimu, který trvá na propagandistické verzi historické události, nikoli na vládě svobodného lidu, vázaného právním státem, hledajícího pravdu. Systém, který nám vládne – federální vláda, zpravodajské agentury, federální donucovací orgány a média, která ospravedlňují své chování – dělají to, co výtržníci 6. ledna 2021 nedokázali. Fatálně podkopávají legitimitu režimu.

Tucker Carlson nedávno odvysílal některé dosud nezveřejněné záběry z 6. ledna. Ukazuje demonstranty, nikoli výtržníky, jak klidně procházejí Kapitolem. Nejvýraznější postavou je <u>Jacob Chansley</u>, "QAnon Shaman", který nosil vikingskou čelenku. Strážci zákona mu prakticky poskytli doprovod a v modlitbě na půdě Senátu poděkoval, že nás policie "[v]pustila do budovy".

První lidé do hlavního města jasně vnikli dovnitř. Jakmile se to stalo, policie si musela uvědomit, že neexistuje žádný způsob, jak udržet ostatní venku. Ale vzdát se boje není totéž jako přivítat demonstranty v budově.

Někteří nazvali výběr videí Tuckera Carlsona stejně tendenční jako výběry z Kongresu "vyšetřování", což nebylo nic jiného než případ pro stíhání. Ale co bychom si měli myslet o lidech, kteří vešli po násilí? Kapitol je velké místo a někteří možná neviděli vůbec nic neobvyklého. Pokud vstoupili do nestřežené budovy, jednali pokojně a po dnech a měsících byli zatčeni, zaslouží si tresty odnětí svobody?

Ať se ten den stalo cokoli, Jacob Chansley měl dostat tyto záběry předtím, než se přiznal k maření jednání Kongresu a dostal 41 měsíců vězení. Právo obžalovaného vidět všechny důkazy – dobré i špatné – je pro americký systém zásadní. Andrew McCarthy v *National Review* <u>napsal</u>, že právníci pana Chansleyho by "trvali na tom, aby jim byl před přiznáním viny předložen jakýkoli potenciálně osvobozující důkaz". Pravděpodobně však <u>nemohli</u>. Jeho právní zástupce nevěděl o nahrávkách, které měl Kongres. Ministerstvo spravedlnosti mohlo říct, že je nemá a nemůže je vyrobit. "Členové a právní zástupci výboru tedy pohřbili záběry, které byly jasně

relevantní doslova stovkám lidí, kteří čelí trestnímu stíhání po celé zemi," říká právní analytik Jonathan Turley. "Udělali to, zatímco opakovaně odkazovali na tyto případy při slyšení jako na podporu právního státu."

Měla FBI nebo jiné agentury v davu lidi, kteří na to možná naléhali? Republikán Thomas Massie (R-KY) chce znát všechny federální agenty, kteří tam byli. "Na těch videích je opravdu zvláštní chování," řekl, "lidé za policejními liniemi v civilu, dotýkají se jich na rameni, mluví do ucha, kolem hranic, jako by tam ani nebyli." Zástupce Massie poukázal na to, že generální prokurátor Merrick Garland odmítl odpovědět na jeho otázku o počtu federálních agentů ve službě. Když nemůže dostat odpovědi kongresman, jak my?

Tucker Carlson poukazuje na to, že když antifa zaútočila na Bílý dům, policie Washington DC odmítla pomoci agentům tajné služby. Řekl, že obě události byly špatné, ale pamatujeme si jen jednu – mnoho lidí je nyní nedůvěřivých, když jim řeknete, že prezident musel být evakuován do zabezpečeného bunkru – protože režim podporuje jednu, ale ne druhou.

Téměř každý týden lidé na Twitteru oslavují černošského policistu Capitol Police, který zastřelil Ashli Babbittovou. Mám podezření, že kdyby důstojník zastřelil výtržníka, který se snažil zaútočit na Trumpův Bílý dům, bylo by s ním zacházeno jako s Derekem Chauvinem a neposkytlo by mu uctívající rozhovor zpravodajství NBC. Stejně tak *New York Times* napsal, že prezident Trump se "scvrkl" a podvolil se tomu, že bude nahnán do bunkru. Není mi znám žádný takový popis prchajících senátorů a kongresmanů. "Whataboutism" je líná forma argumentace, ale musíme ji používat v mediálním prostředí, které tak selektivně vyvolává emoce. Lidé se o George Floyda vášnivě starají, protože jim to novináři řekli. Nezajímají je Channon Christian a Christopher Newsom, dva mladí běloši umučení k smrti v roce 2007 černochy, protože většina o nich nikdy ani neslyšela. George Floyd byl záminkou k prosazení politického poselství o tom, že policie svévolně zabíjí černochy. Příběhy kolektivních médií jsou nyní ústředním bodem americké politiky. Floydova smrt mohla být příběhem o černošském zločinu, užívání drog a někdy fatálních důsledcích odporu při zatýkání.

Jak média reagovala na zprávu Tuckera Carlsona? <u>Politici</u>, novináři a <u>noční hostitelé</u> – v podstatě stejná třída – nejsou šťastní. A skutečně, proti zveřejnění desítek tisíc hodin videozáznamů výhradně jedinému partyzánskému reportérovi, který by je jistě použil selektivně k vytvoření případu, lze vznést silný argument, stejně jako to udělalo vyšetřování 6. ledna. Taková srovnání nám řeknou více o lidech, kteří je provádějí, než samotná událost.

A co nepokoje, které se zemí přehnaly v roce 2020? Výsledkem byly pojistné události ve výši 2 miliard USD a skutečné náklady byly mnohem vyšší. Nejméně 25 Američanů zemřelo. Američané viděli policejní stanici vypálenou do základů, zničené neocenitelné památky a levičáci si na několik dní nárokovali suverenitu nad částí velkého amerického města. Třicet států a DC zavolalo Národní gardu a více než 200 měst zavedlo zákaz vycházení. Počet vražd rekordně vzrostl. V některých ohledech vzpoura stále neskončila.

V roce 2020 policisté před výtržníky couvali, když k nim neklekali. Někteří protestující budou spíše <u>placeni</u> než potrestáni. Bránit se bylo nebezpečné. Kyle Rittenhouse byl zproštěn viny, ale nyní čelí <u>civilní žalobě</u>. Další muž, Jake Gardner, spáchal <u>sebevraždu</u> v roce 2020 poté, co média a demonstranti úspěšně dotlačili velkou porotu, aby ho obvinila ze zabití, a to i poté, co byl původně očištěn v případu sebeobrany. Američanům všech ras, kteří dodržují zákony, bylo možné odpustit, že si mysleli, že je jejich vláda opustila. To je vláda, kterou stále máme.

"QAnon Shaman" nikdy neviděl všechny důkazy. Soudní proces s Proud Boys narazil na zádrhel, protože obhajoba našla "skryté" zprávy FBI, včetně agenta popisujícího příkaz nadřízeného "zničit 338 důkazů". Během škodlivého křížového výslechu svědků ministerstvo spravedlnosti tvrdilo, že omylem "vysypalo" utajované informace do procesu, a soudce nakonec nařídil obhajobě, aby to ignorovala. Neexistuje téměř žádný způsob, jak poznat pravdu, ani zjistit, co FBI říká, že je příliš "utajované", než aby to lidé před soudem viděli. Congressman Jamie Raskin, a Democrat who served on the House select committee investigating the Jan. 6, 2021, attack on the U.S. Capitol, says their final report reveals very real threats to democracy — but also a "strong resurgent democratic spirit" in America today.

"It's a story of some real villainy and some real danger to democracy, but also of real heroism and commitment to American democratic freedom," Raskin said in an interview with Margaret Brennan on "Face the Nation." "And with democracy under attack all over the world, like with Putin invading Ukraine and the Ukrainian people standing up for their democratic freedom, and tyrants and autocrats on the march everywhere, it's good to know that we have a strong resurgent democratic spirit in America."

After an almost two-year investigation, the committee recommended four criminal charges against former President Donald Trump, including conspiracy to defraud the United States and aiding an insurrection. It is not clear if the Justice Department will act on the referral. Last month, Attorney General Merrick Garland appointed special counsel Jack Smith to lead its investigation.

Raskin said the charges are called for "because of the magnitude of the attack on democracy."

"There was a deliberate attempt by Donald Trump to interfere and obstruct and impede a federal proceeding," he said. "...There was a conspiracy to defraud the United States, to exchange an honest-to-goodness presidential election for a counterfeit election complete with fake electors, and forcible violence being used to overthrow the process."
