Návrh zákona říká „nenávistné řeči“, ale Nejvyšší soud existenci takové věci neuznává, takže nový zločin z nenávisti by byl zločinem inspirovaným řečí – prostou, starou řečí – namířenou proti nebělochům nebo zločinem motivovaným záští proti bílé náhradě. Tohle je dost široké. Když řeknu „Sheila Jackson-Lee je zatracený blázen“, je to řeč namířená proti nebělošské osobě. Pokud řeknu: „Nechci se stát menšinou“, je to odpor vůči teorii náhrady. Pokud mě některý z těchto pocitů motivuje k tomu, abych vysypal odpadky na Sheliin trávník – což je zločin – jsem vinen zločinem z nenávisti, a proto dostávám další tresty. Bláznivé věci.

Pokud se dva nebo více lidí „spiknou“, aby vysypali odpadky na její trávník z některého z těchto důvodů, jsou vinni ze „spiknutí“ za účelem spáchání „zločinu z nenávisti inspirovaného nadvládou bílých“.

Co však konzervativce nejvíce rozzlobilo, je toto: Myslí si, že když jsou dva lidé a jeden mluví o Velké náhradě nebo o tom, jaká je Sheila idiot, a pak druhý vyhazuje odpadky, jsou vinni oba. #### Jury Verdict

The jury returned a verdict finding that Plaintiffs had proven each element of their Virginia state law civil conspiracy claim against all Defendants, including that each Defendant was a member of that conspiracy, and therefore finding all Defendants liable for Virginia state law civil conspiracy (Count III). Dkt. 1478 at 3. The jury did not reach a verdict on Plaintiffs’ claim that Defendants conspired to commit racially motivated violence in violation of 42 U.S.C.



Ale pokud federálové řeknou, co je správné a co špatné, ten otravný První dodatek se musí ostříhat a Harvard University Press vysvětluje, proč by měl. Tato kniha *The Harm in Hate Speech* říká, že pokud říkáte věci, které podkopávají „důstojnost“ „zranitelných menšin“, je to stejně špatné jako fyzické napadení a mělo by to být nezákonné. To je běžný pohled. Průzkum organizace First Liberty z roku 2019 zjistil, že 51 procent Američanů si myslí, že první dodatek by měl být přepsán tak, aby zakazoval „nenávislné projevy“.

## Scrap and Rewrite the First Amendment?

The CFS survey asked Americans if they thought the First Amendment, written over 200 years ago, goes too far in allowing “hate speech” and if it should be updated to reflect today’s cultural norms.

Shockingly, more than half of Americans (51%) responded that the First Amendment is outdated and should be rewritten.


