Pamatujete si na tu dobu, kdy byli dva potulní černoši vyhozeni ze Starbucks za to, že si nic nekoupili?

Pamatujete si, že v reakci na to Starbucks prohlásil, že všechny jejich obchody se nyní stanou útulky pro bezdomovce, kde se černoši mohou jen tak poflakovat, nabíjet telefony, prodávat a konzumovat drogy a spát. Starbucks skončil v nějaké krizi a musel zavřít spoustu obchodů, protože lidé neplatí 7 dolarů za kávu, aby je mohli nadávat bezdomovci.

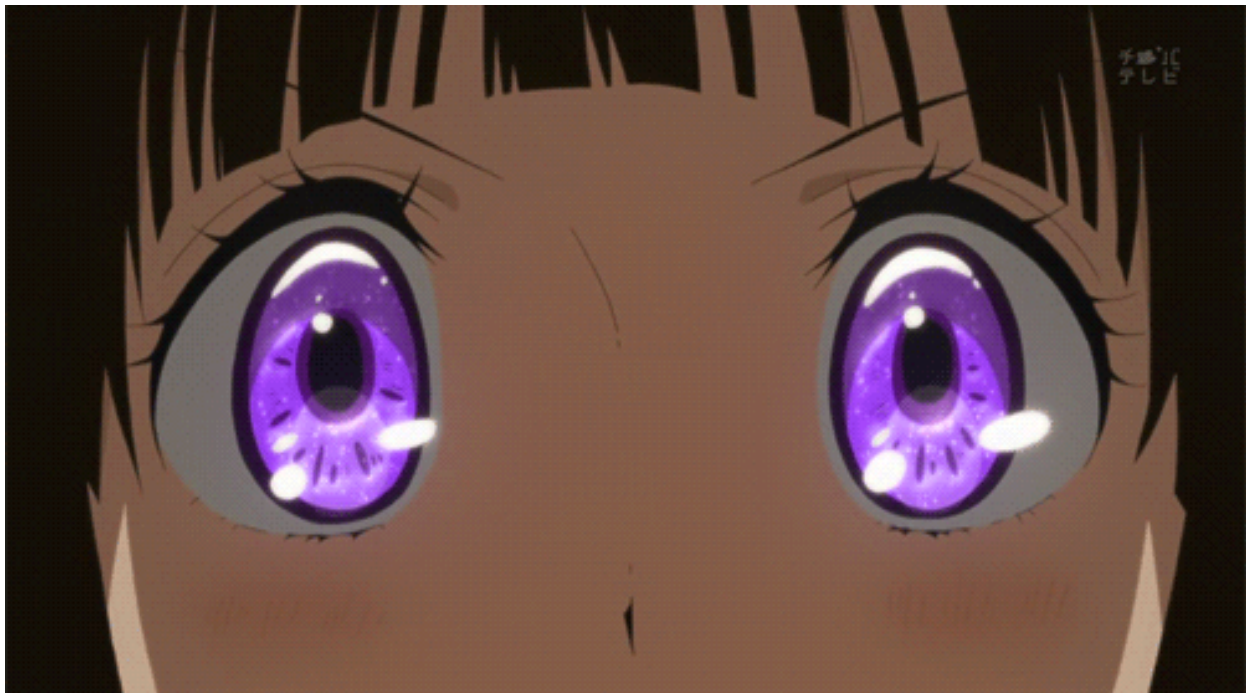

Porotci u federálního soudu přisoudili 25,6 milionu dolarů bývalé regionální manažerce Starbucks, která tvrdila, že ona a další bílí zaměstnanci byli nespravedlivě potrestáni po zatčení dvou černochoů ve Philadelphii v roce 2018.

Shannon Phillipsová v pondělí vyhrála 600 000 dolarů jako odškodné a 25 milionů dolarů v represivním odškodném poté, co porota v New Jersey zjistila, že rozhodujícím faktorem při Phillipsově propuštění byla rasa, což je v rozporu s federální a státní antidiskriminací.



V dubnu 2018 zavolal vedoucí prodejny ve Philadelphii policii na dva černochoy, kteří seděli v kavárně, aniž by si něco objednali. **Phillips, tehdejší regionální manažer operací ve Philadelphii, na jihu New Jersey a jinde, nebyl zapojen do zatýkání. Řekla však, že jí bylo nařízeno dát bělošskému manažerovi, který také nebyl zapojen, na administrativní volno z důvodů, o kterých věděla, že jsou nepravdivé, podle její žaloby.** Phillipsová řekla, že byla vyhozena o necelý měsíc později poté, co vznesla námitku proti tomu, že manažer dostal kvůli rozruchu volno, podle její žaloby.



Důvodem společnosti pro suspendování ředitele distriktu, který nebyl odpovědný za obchod, kde došlo k zatčení, bylo tvrzení, že manažeři černých obchodů dostávají podle žaloby nižší plat než manažeři bílých. Phillips řekl, že tento argument nedává smysl, protože okresní manažeři nemají žádný vliv na platy zaměstnanců.

Žaloba tvrdila, že Starbucks místo toho podniká kroky k „potrestání bílých zaměstnanců“, kteří pracovali v oblasti, „ve snaze přesvědčit komunitu, že na incident správně zareagovala“.

Během závěrečných řečí v pátek Phillipsova právnička Laura Mattiacci řekla porotcům, že společnost hledá „obětní beránek“, aby uklidnila rozhořčení a ukázala, že podniká kroky, uvedl Law360. Vybrat černošského zaměstnance pro takový účel „by jim vybuchlo do tváří,“ řekla.

Starbucks popřel obvinění Phillipse s tím, že společnost potřebuje někoho se záznamem „síly a řešení“ během krize a nahradila ji regionální manažerkou, která měla takové zkušenosti, včetně navigace po bombových útocích na Bostonském maratonu v roce 2013, uvedl Law360.

Phillipsův právník však citoval dřívější svědectví černošského okresního manažera, který byl zodpovědný za obchod, kde došlo k zatčení, který Phillipsovou popsal jako někoho milovaného svými vrstevníky a po zatčení pracoval nepřetržitě.

V e-mailu pro The Associated Press Mattiacci potvrdil výši odměny a uvedl, že soudce zváží přiznání zpětného a budoucího platu, stejně jako odměny za právní zastoupení.

Při incidentu v dubnu 2018 byli Rashon Nelson a Donte Robinson zatčeni v kavárně Starbucks poblíž Tony Rittenhouse Square ve Philadelphii krátce poté, co manažer zavolal policii, aby oznámil, že dva muži odmítají buď provést nákup, nebo opustit prostory. Později byli propuštěni bez obvinění.

Video ze zatčení vyvolalo celonárodní pobouření a vedlo současného generálního ředitele Starbucks k tomu, aby se mužům osobně omluvil. Společnost se později s oběma muži vyrovnala za nezveřejněnou částku a nabídku bezplatného vysokoškolského vzdělání. Společnost také změnila zásady obchodů a na odpoledne uzavřela pobočky po celé zemi kvůli školení o rasové zaujatosti.
